I specifically consent to the digital compositing or distortion of the portraits or pictures, including without restriction any changes or alterations as to color, size, shape, perspective, context, foreground or background. I waive any right that the minor or I may have to inspect or approve any finished product or products or the advertising copy or printed matter that may be used in connection such photographs or the use to which it may be applied. I release, discharge, and agree to hold harmless and defend Photographer, his/her legal representatives or assigns, and all persons acting under his/her permission or authority or those for whom he/she is acting, from any liability by virtue of any reason in connection with the making and use of such photographs, including blurring, distortion, alteration, optical illusion, or use in composite form, whether intentional or otherwise, that may occur or be produced in the taking of said picture or in any subsequent processing thereof, as well as any publication of them, including without limitation any claims for libel or violation of any right of publicity or privacy. I hereby warrant that I am at least 18 years of age and have the full legal capacity and right to execute this release as the parent or legally appointed guardian of the minor. I state further that I have read the above Model Release Form prior to its execution, and that I am fully familiar with the contents of it. This release shall be binding upon the minor and me, and our respective heirs, legal representatives, and assigns. This agreement constitutes the sole, complete and exclusive agreement between Photographer and the minor and me regarding the images and I am not relying on any other representation whether oral or written.
